"At the heart of American democracy is the basic to significantly higher signature requirements right to vote. This treasured privilege has been earned through struggle and is the very foundation of our freedom. It is the right on which all other rights hinge.

With a combined 40 years of military service, we stand alongside many other brave Americans devoted to upholding the principles of freedom and fairness.

Beyond a history of service and love of country, as many as 6 in 10 veterans proudly call ourselves independent voters.

In Arizona, systemic barriers entrenched within our electoral system are designed to disenfranchise voters like us and prevent candidates who genuinely reflect our interests from getting on the ballot. These obstacles disproportionately complicate veterans' ability to have a say in selecting the future commander-inchief.

Requiring independent voters to re-register with a party simply so we can exercise our right to vote in elections we pay for contradicts the very act of disassociating from a party that no longer reflects our values.

Moreover, independent candidates are subjected

up to six times more signatures than Republican or Democratic candidates - unfairly hindering their ability to qualify for the ballot.

Even if a candidate overcomes these hurdles their name will not appear on primary ballots, like R and D candidates, but instead will only appear on the general election ballot.

Veterans have sacrificed a great deal for us. Is it fair to deny them the freedoms enjoyed by the parties they don't identify with and expect them to sacrifice more to participate in the primary elections their taxpayer dollars pay for?

Our system should facilitate and make the opportunity to vote or run for office open to everyone. Change requires courage. But we're all too familiar with the candidates that benefit from preserving status quo. The ones that prioritize party allegiance over what's best for their country.

It's time we put the nation's interests above party politics and reignite the spirit of cooperation and teamwork that has historically fueled our country's success. Our democracy thrives when every citizen's voice is heard. Let's treat all voters and candidates equally. Join the fight for fair elections in Arizona."

70% turnout will decide the winners by majority vote, while primary elections with a 30% turnout will only narrow the field.

- Inclusive Voting: Independent voters can participate without choosing a party ballot or re-registering.
- Encourages Cooperation: Politicians can work together without fear of losing their seats in the next primary for compromising for the common good.
- Nonpartisan Solution: The MEF Act benefits voters without favoring any party.

# The Value of Wisdom in Politics

"Wisdom is valued because it is so rare. Wisdom in the current conduct of elections is an even rarer commodity. We have a chance to fix all this.

This November, Arizona voters will be offered an opportunity to celebrate political wisdom by supporting Proposition 140, the Make Elections Fair Act. Prop 140 wisely cements equality in our electoral process. It ensures that every voter and every candidate is treated equally under the law, combating partisan extremes, and promoting fair competition.

The modern Arizona electorate is near evenly divided between Republicans, Democrats, and independent voters. But today, the third of Arizona voters who are independents can't participate in primary elections equally with their two-party brethren even though their taxpayer dollars help fund them. And if an independent candidate wants to get on the ballot, they must collect six times as many signatures. Prop 140 wisely gives all voters and all candidates equal status when it comes to ballot and voting access because all candidates will be on the same ballot.

Even more dramatic is the fact that 80% of current Arizona legislative or congressional general election candidates have virtually no meaningful competition. These elections almost always are decided in the partisan primaries. Prop 140 sensibly guarantees that no candidate can win their seat outright in a primary election and that everyone will



face a competitive, free-market style general election.

The State Legislature along with the Governor - with the help of election officials - will then decide how the general election will be run, with one clear rule: partisan preference will have no weight in choosing who moves forward to compete in a general election.

Our second President, John Adams, was concerned about fair and equitable competition at our Nation's founding. "<u>There is</u> <u>nothing I dread so much, as a division of the</u> <u>Republic into two great Parties, each arranged</u> <u>under its leader and concerting measures in</u> <u>opposition to each other," Adams stated. "This</u> <u>in my humble apprehension is to be dreaded</u> <u>as the greatest political evil, under our</u> <u>Constitution."</u>

Prophetically, those fears are presently manifest in entrenched political regionalism, divisive political factionalism, and foreign interference by way of global communication and suffocating disinformation.

Most lamentable, they are dictated and advanced by the duopoly of the Republican and Democratic parties. Combined, these pose an imminent threat to our capacity to unify as Americans.

With the illumination of this wisdom, selfexamination and courage, there are decisions to be taken which can blunt this headlong sprint to authoritarianism or anarchy, both of which produce no viable offspring.

Good old-fashioned free-market competition will prudently save our democratic Republic if we simply end outright two-party control. Honor the individual over the party, honor the country over the party. Honor principle over the party.

<u>While some will appeal to hold onto a strict</u> <u>partisan tradition, to do so will deny one's own</u> <u>future liberty.</u> We must permit every voter to participate in each election of their choosing. We must make every election equal and fair.

Enacting Prop 140 will infuse this wisdom in the conduct of Arizona's elections.

Please join us in this prescient effort to right our electoral ship as it sails to what Ronald Reagan referred to as 'the shining city on the hill.'

Vote yes on Prop 140. Better choices, better candidates, better outcomes. Better for Arizona. Better for our Republic."




## FAIR ELECTIONS VOTER GUIDE

**Proposition 133** enshrines the current dysfunctional primary system into law where a small, partisan minority select who will represent us all. It requires partisan primaries and excludes 1.4M independent voters from participating in elections their tax dollars help pay for. Prop 133 was referred to the ballot by partisan state lawmakers in direct opposition to Prop 140.

**Proposition 140** establishes open primaries and requires that all voters and all candidates be treated the same under the law. Prop 140 permits all candidates regardless of party affiliation to compete under the same rules and be placed on one primary ballot and prohibits the use of taxpayer funds for partisan elections

We support open primaries because we think they will discourage extreme politics and encourage candidates to appeal to the broader electorate rather than the narrow partisan interests of a particular political party. We also believe open primaries will encourage more and better candidates to run.

# PROP. 140 FAQ'S

#### WHAT IS AN OPEN PRIMARY?

In an open primary, all candidates will appear on the same ballot and compete under the same rules, and all registered voters will use that same ballot to cast their vote for their preferred candidate(s). In an open primary, the use of taxpayer funds to pay for private political party primaries would be prohibited.

#### WHAT CHANGES?

- Every Voter, Every Election: any registered voter can vote in any election for any candidate they want.
  - Currently: the partisan primary system, paid for by all taxpayers, excludes voters not affiliated with a political party from participating. A voter who does not belong to a party must select a party ballot to vote in a Primary election.
- Stop Politics of Division Build Consensus: encourages candidates to be responsive to all constituents and combats the politics of division and incentivizes candidates to prioritize the issues we agree upon.
  - **Currently:** our system of voting for the lesser of two evils rewards elected politicians that do not focus on the issues we care about most.
- Competition Produces Better Choices: makes elected officials accountable to most voters and leads to better choices, better results, and a stronger Arizona.
  - **Currently:** 70% of Arizona voters DO NOT believe our elected officials are focused on the issues they care about most.
- Your Voice and Your Vote Matter: open elections will give voters equal opportunity to weigh in on who is elected. Your vote will always matter even if your first choice is eliminated.
  - **Currently:** our summer primary election system is by far the most visible way we have turned power over to our most partisan, polarized citizens.
- Equal Treatment: treats all candidates and voters equally by allowing them to compete under the same rules.
  - Currently: unaffiliated candidates must collect more than 6x the number of signatures and do not appear on the primary ballot.

Free enterprise is essential for our capitalistic economy. It gives entrepreneurs the opportunity to start businesses, work hard, be successful and grow local economies.

In addition to freedom for office-seekers to compete and freedom for voters to choose from all candidates, voters have another reason to support open primaries.

All taxpayers are stuck bankrolling partisan primaries that exclude

Under this system all businesses, small and large, compete on a level playing field, and consumers have the freedom of choice.

Supporters of these free enterprise principles that welcome competition, and encourage choice, should support extending these practices beyond the business world and into our political system.

These concepts fuel economic vitality and would reinvigorate our democracy. Unfortunately, that is not the case in Arizona. All political candidates, regardless of party or no party, should be allowed to compete fairly for the support of the voters. All voters should have the freedom to select from all candidates who they deem best suited for the job.

#### Opposition driven by fear of real competition should not stand in the way of these electoral freedoms.

Independent voters face hurdles to cast a primary ballot. Unaffiliated candidates have no access to primary ballots and are required to gather up to six times the number of signatures compared to partisan counterparts just to be listed on the general election ballots. A3

all independent candidates and dissuade most independent voters from casting a ballot.

#### Clearly, this is taxpayer-funded discrimination based solely on party affiliation.

A fairer system would eliminate these barriers and create open primaries where all candidates for a public office compete under the same rules and appear on the same ballot, and all voters regardless of party affiliation have equal access to participate in the elections that their tax dollars support.

More than 559,000 Arizonans signed petitions to put the open primaries measure on the November ballot, far surpassing the required 383,923 signatures. The public's support for this initiative is clear.

But those aiming to preserve the current closed partisan primary system are working to keep electoral discrimination alive by denying the freedom to compete and choose.

Those who support democracy, freedom to compete and freedom of choice are holding their breath.

## **Unfair Barriers for Voters & Candidates**

How is our election system unfair for voters and candidates?



#### WHAT IS THE PROBLEM?

- Our elected officials from both parties are not delivering the results we want, need, and deserve because our primary election system is unfair and fundamentally broken.
- Despite being the largest registered group in the state, independent and unaffiliated voters are not treated fairly.
- Candidates who choose to be independent face significant barriers to participation including massive signature requirements.
- Most elected officials win outright in narrow primaries where very few voters participate, and independent candidates are excluded.
- These primaries reward negativity, foster division, and neglect the issues the voters care most about. Compromise is punished and our state is prevented from solving its biggest problems.

#### WHAT DOES PROP 140: THE MAKE ELECTIONS FAIR INITIATIVE DO?

- Treats all voters equally (including independents) by allowing them to vote in every primary election for any candidate they want.
- Treats all candidates fairly by creating a single open primary election where all candidates for a given office appear on the same ballot and have the same signature requirements.
- Restricts taxpayer money to only elections that are open to all voters and candidates, not private party elections.
- Provides guidance for the General Election At least the two highest vote getters in the Primary Election, and no more than five, move on to the General Election. If there are more than two, rankings must be used to determine the ultimate winner.

#### WHY DOES THIS MATTER?

- Every registered voter in every community should be able to vote in every election for any candidate they want. This will make our elected officials more accountable to all voters.
- Increased accountability will force our elected officials to focus on problem solving and addressing the most important issues facing Arizona.
- Competition reduces negativity, increases civility, and makes it much more difficult for candidates on the ideological extremes to win in a General Election.



# THIS NOVEMBER, ARIZONA COULD CHANGE THE RULES OF ELECTORAL POLITICS



Arizona is center stage for every issue that Democrats and Republicans are using to drive votes...Immigration, abortion and the rise of the Latino electorate. Climate change. Election denialism and election protectionism. Inflation and tax policy. It's all front and center in Arizona politics, one of the last remaining competitive states in the country.

But right below the surface, another seismic issue is making its way to the ballot this November: a referendum to change the rules of the political game itself. Conventional pundits may be ignoring democracy reform in favor of traditional policy debates, but voters aren't. More and more states are exploring reform, and what's happening right now in Arizona could be a significant game-changer for the entire country.

Last year, independents tied Republicans as the largest group of voters in the Grand Canyon State. It's right there in the voter registration data: 1.4 million Republicans, 1.4 million independents, 1.2 million Democrats. This rapid rise of independent voters echoes a national trend but is amplified in Arizona because of how evenly matched the two parties are with each other. Independents have become the kingmakers.

But the lived experience of independents in Arizona is that they are second-class citizens.





Independent candidates must collect six times the number of signatures compared to party candidates — and even if they clear that hurdle, they don't appear on the primary ballot.

And Arizona completely bars independents from participating in the presidential preference elections that their tax dollars pay for!

A diverse group of Arizona citizens is working to level the playing field and, with largely local funding, has founded Make Elections Fair AZ to empower independents and revitalize the state's political culture...Part One would create a nonpartisan first round election so all voters and all candidates are on equal footing and voters can choose from among all the candidates. Part Two is an open presidential primary that would allow all citizens to cast a ballot. If the parties want to restrict participation, they can — but only if they pay for the private election themselves.

Why is restructuring primary elections so important? In Arizona, almost half of all general election races for state legislature in the last cycle ranged from outright uncontested to complete blowouts. Less than a quarter of all races were competitive in November. Nonpartisan primaries will create genuinely competitive general elections in every corner of the state.


At a time when the Democratic and Republican playbooks are built around "divide and conquer" and "do anything you have to get 50.1 percent," the Make Elections Fair team is putting basic American values that have wide cross-partisan appeal on the ballot. Treat all voters and candidates the same.

Let all voters vote for whomever they want in every taxpayer funded election. Competition, not coronation.

And this referendum, if it passes, won't cut the people's elected leaders out of the picture. The legislature will have to design a new system that treats all voters and all candidates fairly and equally, opens the presidential primaries, and combines a nonpartisan

In Arizona, like in many other states, election administration is partisan. Independents have no representation on boards of elections and can't serve as poll workers or election judges. The state has open primaries for downballot races but forces independents to "pick a party" in order to participate. That's at odds with what Thom Reily of ASU's Center for an Independent and Sustainable Democracy recently noted: "The defining feature of independents is that candidates and issues, not party loyalty, drive their choices."

Arizona has mail-in voting, but independents must jump through Kafkaesque hoops to receive a primary ballot. primary for state and federal races with a competitive general election in which the winner gets a clear majority.

The current rules in Arizona empower small groups of partisan insiders and muzzle independents at precisely the time when their voices are needed to counteract the 24/7 warfare between Team Blue and Team Red. The Make Elections Fair team has created a vehicle to propel the values of fairness, competition and inclusion onto center stage, at precisely the moment when our country desperately needs them.

Prop 140: A voter-led initiative headed to the November ballot aims to fix Arizona's Primary Problem, give voters better choices

A mere 4% of Arizona voters elected 78% of its U.S. House seats in last week's primaries, according to a new analysis from Unite America Institute. Arizona's "Primary Problem" is largely the result of uncompetitive general elections — just two out of nine districts in the state are considered competitive, according to The Cook Political Report.

To fix Arizona's Primary Problem, a bipartisan coalition led by Make Elections Fair Arizona [has put Prop 140 on] the November ballot that would abolish party primaries and replace them with a single all-candidate primary. In open all-candidate primaries, which four states currently use for state and federal offices, all candidates compete on one ballot and every eligible voter can participate.

Last month, Make Elections Fair Arizona turned in more than 580,000 voter signatures in support of the initiative — far more than the 383,923 valid signatures required.

"Arizona is Exhibit A for the Primary Problem this week, but Arizona voters are also showing us that party primaries are the most solvable problem in politics. We're inspired by the 580,000 Arizonans — and 1.5 million voters across six states nationwide — who have signed on in support of open primaries and fairer elections this year."

"Arizona's current system favors partisanship since more than 80% of all legislative races are determined in primaries from which independents and unaffiliated voters are excluded.

If you are a member of either of the two big parties (like I am), you can take this opportunity to ensure that ALL voters and candidates will be treated fairly.

Because of gerrymandered legislative districts, most elections in Arizona are determined in the primary. You win in the primary and you're almost sure to win in the general. That would be fine if our primaries were fair, but are they?

**IS IT FAIR** that to run for statewide office, Independent and unaffiliated candidates must collect nearly 6 times the signatures compared to R or D candidates?

**IS IT FAIR** that even if an Independent candidate overcomes these hurdles, their name will not appear on primary ballots, like R and D candidates, but only on the general election ballot?

**IS IT FAIR** that 34% of registered voters not affiliated with the two big parties must request a partisan R or D ballot to vote in a Primary election?

This amendment will: Eliminate partisan primaries, replacing them with a system where individuals may vote for the candidate of their choice, regardless of the voter's or candidate's party affiliation. Create the same signature requirements for those wishing to run for a particular office, without regard to political party affiliation or lack thereof.

On behalf of the Southern Arizona Leadership Council (SALC), a nonpartisan policyfocused organization of business and community leaders who work to enhance the economic climate and quality of life in our region and state, I urge you to vote YES on Proposition 140!

Arizona's primary system currently disenfranchises citizens of all political affiliations. With 80% of Arizona's legislative districts being "safe" for one party, the primary is the only election that matters. Due to the system, only about 10% of the 1,369,644 Independents or 'Party Not Declared' (PND) registered voters participate in the primary. In Arizona's 2022 general election, 19 of 90 legislative seats (21%) were uncontested and those candidates ran unopposed. They were effectively elected in the primary which is closed to voters from the minority party and presents significant hurdles for Independents/PNDs. This is undemocratic.

Prop 140 will give all Arizonans a fair chance to participate in our democratic process.

In my mind, one of the most important opportunities to improve our current faltering system is on the ballot this year. It's Proposition 140 aka "Make Elections Fair." It's casually referred to as the "open primaries" initiative. Personally, I believe that the "open primaries" initiative, while not perfect, is our best shot to improve our current unbalanced and unfair "closed" partisan primary system, and possibly improve voter turnout and the quality of our elected officials in the future.

First, let's look at the recent 2024 primaries here in Arizona as an example of how poorly the current system works. Overall, just 31% of all registered voters participated in primaries at all.

participated, 31% of Democrats, isn't fair and just 7% of Independents! In short, the primary voters under the current partisan system do not represent anywhere near a majority of all voters, even within their own party. Add on top of this that 80% of our districts in Arizona are non-competitive due to gerrymandering. This means that whoever wins the "partisan" primary wins the general election, meaning that all the rest of us who did not participate in that party's primary have no vote whatsoever!!!

Frankly, I take this personally because I am an "unaffiliated" or independent voter. People like me represent the largest voter category nationally, and the fastest growing segment of the Arizona electorate. Current registration in Arizona as of July 2024 is 35% Republican, 34% Independent, and 29% Democrat with the remaining 2% split amongst up libertarians, greens, etc.

As we have seen in the current partisan primary system, the democratic base generally votes for someone to the far left, and the republican base usually votes for someone to the far right, and in the general election we are left to choose between two extreme candidates.

Whether Republican, Democrat. Unaffiliated, etc. a majority of voters identify closer to the center, not the extremes. Not sure about you, but I often find myself voting "against" an extreme candidate rather than voting "for" a candidate | support!

Proposition 140, the "Make Elections Fair" initiative, "opens" the primaries by having all candidates regardless of party run on the same ballot, and ALL voters regardless of party (or unaffiliated) can vote in the primary. The initiative then leaves it up to the Legislature to determine going forward whether the general election is a runoff between the top two vote getters or "up to" the top five.

Of that, 33% of Republicans **Current system** Interestingly, two of our founding fathers who also happen to be our first two presidents were concerned

> about devolving into a two-party system. John Adams wrote: "There is nothing which I dread so much as a division of the republic into two great parties...This, in my humble apprehension, is to be dreaded as the greatest political evil under our Constitution." In George Washington's farewell address, he said: "However [political parties] may now and then answer popular ends, they are likely in the course of time and things, to become potent engines, by which cunning, ambitious, and unprincipled men will be enabled to subvert the power of the people and to usurp for themselves the reins of government..." Simply put, our current system isn't fair, and not the way it was intended.


An independent candidate is required to gather up to six times the amount of signatures as a partisan candidate and still won't appear on the primary ballot.

### LAWMAKERS' BALLOT MEASURES BLOCK ELECTION REFORM

In an opinion published in the Arizona Capitol Times on Aug. 1, 2024, "Election Reform Voters Have Been Waiting for, Finally", Al Bell correctly argued that Proposition 140, better known as the Make Elections Fair Act, represents an opportunity to improve both our elections and our state government.

Unfortunately, just passing Make Elections Fair this election is not enough. The state Legislature has referred several propositions to the ballot to undermine efforts at reform. It is unsurprising that those who have benefited from the status quo wish to keep things as they are. Here are three legislative referrals that voters need to be aware of in addition to Make Elections Fair.

Proposition 133 is the Legislature's attempt to permanently enshrine the current partisan primary system, which is precisely what the Make Elections Fair Initiative is trying to reform. If you are in favor or Make Elections Fair, then you should definitely vote "No" on Proposition 133.

If you are not sure about the Make Elections Fair Act, you should still vote against Proposition 133, because making the current broken system forever unchangeable is a bad idea.
